Sub: Request for details of medical treatment given to Shri M. Vijayavarman and Shri D. Samayaraj – reg.

Shri. Samayaraj IC.No.: 10555, TO/D & Shri M. Vijayavarman, IC.No.:6915, SO/D are AERB licensed Junior shift engineers (JSEs) for Round The Clock shift operation of Fast Breeder Test Reactor (FBTR) FBTR has 7 such JSEs out of which 4 will be in regular shifts and 3 will be on standby who will attend RTC shift duty during the non-availability of any shift engineer due to leave, sickness or any other personal emergency. These JSEs are qualified and licensed by AERB after a rigorous training programme spanning over 4 years by clearing system check lists, conducting walk through interviews and a final interview by a AERB constituted licensing committee.

In the recent past, two ISEs (Shri.O.Samayara) & Shri.M.Vijayavarman) are refusing to attend RTC shift duties quoting ill health as the reason. Because of this, the strength of ISEs has come down to 5 and FBTR is finding very difficult to run the RTC shift operation of FBTR which is an operating nuclear reactor. The brief details of the reported illness of (Shri.D.Samayaraj & Shri.M.Vijayavarman) are given below

Since 7° October, 2020, Shri, Samyaraj has become highly irregular and claiming that he is under mental depression due to lack of appreciation from the organization. He is absent for more than 70 days so far. He is refusing to attend round the clock shift duties quoting the same. He has submitted medical certificates from private and non DAE hospital doctors for regularizing his absence without proper intimation to his superior officer. Of late he has informed that he is undergoing treatment at Chettinadu hospital on being referred by DAE hospital. He did not produce any proof in support of this.

Shri M. Vijayavarman is also found to be highly irregular in attendance and remained absent for 145 days since 17th July '20. He is refusing to attend round the clock shift duties quoting illness (pain on his lower back and juints due to Psoriatic Arthritis). As reported by him, he is taking medical treatment for the above from IMPCOPS hospital on being referred by DAE hospital

"As stated above, the continued absence of the above two officials from attending RTC shift duty citing medical reasons is causing lot of disruptions in the functioning of FBTR operations. There is only one ISE for relieving 4 regular shift engineers and this pose a grim situation in the operation of FBTR. At present, other than the statements of Shrl.D.Samayaraj & Shrl.M.Vljayavarman, the section does not have any records regarding their reported illness. In this context, it is requested to provide us with the details of their latest medical condition so that next course of action can be decided.
