Awareness is created among employees about sexual harassments and the repercussions through presentations on the topics “Do nots towards Women employees at work place. “</li><li>2. Multiple sessions are conducted in each group to create awareness.</li><li>3. Further legal experts are invited to give lectures on the topics.</li><li>4. The members of the ICC committee are provided with training to be aware of their responsibilities. Members were nominated to attend training programs like “Prevention of Sexual Harassment of women at work place.”</li><li>5. Wide publicity is given about the committee and how to approach them in case of need.</li><li>6. Monthly and annual reports are filed in time.
