How many fire incidents (both reportable and non-reportable) occurred in various DAE constituent units i.e. BARC, NPCIL, NFC, HWP RRCAT, VECC etc. supply the full fledged data for fire calls as well as rescue operations attended by Fire Service Staff of DAE in DAE unit premises as well as outside the premises for last 05 years.	In IGCAR a total 11 numbers of fire incidents (refer annexure-I) were reported to AERB from (2018-2022). Rescue operations were attended by Fire Service Staff of NPCIL, MAPS. The full fledged data for fire calls as well as rescue operations attended by Fire Service Staff of this Centre during 2018-2022 shall be obtained by paying a fee of Rs.6/- (Rs.2/- per page X 03 pages) which shall be remitted by way of cash against proper receipt or by demand draft or bankers cheque or Indian Postal Order payable to the Pay & Accounts Officer, IGCAR, Kalpakkam.
03.	Provide information on what is the present status of risk and hardship allowance for Fire Service Staff in DAE.	At present DAE, Fire Station, Kalpakkam was inducted by CENTRAL INDUSTRIAL SECURITY FORCE, Fire Wing who are directly reporting to Ministry of Home Affairs. During (2018-2022) Fire Service Staff, DAE Kalpakkam were administratively reporting to HR Department, NPCIL, MAPS, Kalpakkam. Hence no specific information/records are available.
04.	when fire incident occurred at any DAE constituent units like NFC, HWP, BARC, RRCAT, VECC etc. then by whom such calls are being attended?	For any fire incident occurred at IGCAR, all fire calls are being attended by CISF, Fire Wing, DAE, Kalpakkam. During (2018-2022) all fire calls were attended by Fire Service Staff of NPCIL, MAPS, Kalpakkam.
